

**Course Syllabus – CJ 2360 – Fall 2013 - Juvenile Law & Procedure - Dr. Michael Tatum**

**Course Description:** Examines the history/development of laws dealing with juveniles and procedures used both past and present in dealing with juveniles with emphasis placed on Utah law. Provides a foundation for those interested in careers and work with juveniles, including corrections, probation, security, law, or criminology.

Prerequisites: ENGL 1010 (Grade C or higher) and CJ 1010.

**Book Report:** A book report will be due December 3<sup>rd</sup>. The book must be instructor approved. The format of the book report will follow the Lifelong Learning (GONG) approach and format which will be explained in class.

The book report will carry the weight of one exam.

**Other Required Assignments:** There *may* be 10-20 out of class assignments which will carry a cumulative weight of one exam. All assignments, including the book report, must be typed to receive full credit.

**Grading:** All exams will carry the weight of 100 Points. Traditional university grading scale will apply: A=90-100 / B=80-89 / C=70-79 / D=50-69. Minuses and Pluses will only be used to enhance grades and reward attendance and participation. Late work assignments and exams will receive a 10% deduction in value.

The major Historical trends and landmarks from 1792 BC to the American Colonies to the present, including both Legal and Social Definitions that describe What Delinquency is and Who is a Delinquent and How Delinquency has been and is Measured today. To include the Uniform Crime Report, Victimization Surveys, and Self-Report Studies. / Trends related to sex, race, social class, and age as covered by past and current Research. Glossary and Terms. – **Exam.**
- ✓ **Section 2** - Chapters 3-6 - *Students will be able to explain, describe, identify, and understand the following:* The major Delinquency Theories and theorists and their related research, to include: Choice, Biological, Psychological, Cultural Deviance, Strain, Social Control, Labeling, Conflict-Marxist, and Developmental. Glossary and Terms **Exam.** – Note the possibility of a second exam over this section.
- ✓ **Section 3** – Chapters 7-10 – *Students will be able to explain, describe, identify, and understand the following:* The Social Context of Delinquency as it relates to the Family and changing Family Dynamics / Schools and educational-learning environment / Schools, Safety, and the Law / Violence / Drug Use – Prevention and Treatment / Impact and influence of Peer Groups and Gangs / Applications of Intervention and Prevention. Glossary and Terms **Exam.**
- ✓ **Section 4** – Chapters 11-14 - *Students will be able to explain, describe, identify, and understand the following:* The workings and legal ramifications and legal sanctions of the Juvenile Justice System, with emphasis on the Role of the Police, the Courts, and Corrections and how each operates in their individual handling of juvenile delinquency cases. Emphasis will be placed on both identification of delinquents and Prevention of Delinquency. Glossary and Terms. **Exam.**
